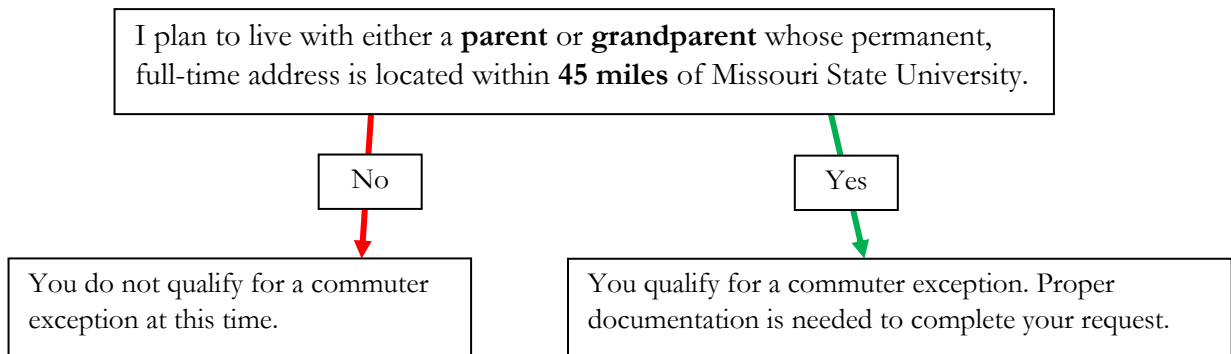


All single students under 21 years of age who have earned fewer than 27 hours of transferable credit after high school graduation are required to live in University housing.

Am I Qualified for a Commuter Exception for 2021-2022?



What Documentation is Needed to Compete My Request?

If living with a **PARENT**:

- *Request for Commuter Exception Form* signed by parent.
- Address on *Request* must match **Permanent Address** on file with Missouri State University. Change of address form may be required.
- **Proof of parent address****

If living with **GRANDPARENT**:

- *Request for Commuter Exception Form* signed by parent.
- Address on *Request* must match **Permanent Address** on file with Missouri State University. Change of address form may be required.
- Letter from grandparent verifying living arrangement.
- **Proof of grandparent address****

**Accepted proof of address for the parent or grandparent the student intends to live with are as follows:

- Driver's license for parent or grandparent that shows same address on *Request Form*
- Mortgage statement for parent or grandparent that shows same address on *Request Form*
- Current rental agreement that shows same address on *Request Form* and lists parent or grandparent that signed the request as well as student as tenants of the property.
- Utility bill for most recent month of service to same address on *Request Form* in the name of the parent or grandparent the student intends to live with.

All needed documentation not signed in the presence of a Residence Life staff member **must be notarized** by a Notary Public. If you have questions about this process contact Residence Life, Housing and Dining Services at 417-836-5536.
